Tournament Rules

1. C-U 600 Bowling Club shall conduct an all area tournament; all entrants must be members of USBC. Total entries combined for all divisions not to exceed 120. All entries received above the 120 limit will be placed on a waiting list, entry form and fee will be held until February 15, 2019. Each division has its own prize fund and winner:

130 and under average	131 thru 149 average
150 thru 169 average	170 thru 189 average
	190 and over average

2. Average to be used in following order:
 - a. Last season's highest USBC book average of 21 or more games.
 - b. If (a) does not apply, 2018 summer league average based on 21 or more games.
 - c. If your current 2019 average, 21 games or more as of February 14, 2019, is 10 pins higher than your 2017-18 average you must use this years average. (new rule adopted 2017)**
 - d. If neither (a) or (b) apply, use highest current season USBC average as of January 31, 2019 of 12 or more games.All averages will be verified before bowling, if average given is incorrect, change will be made and proper division assigned.
USBC rule 319a, item 2 and rule 319d do not apply. Rule 319e is waived.

3. Entries must be in tournament manager's possession by midnight February 15, 2019. Refunds allowed if tournament manager is notified in writing, e-mail acceptable, of tournament withdrawal by 9:00 pm, Friday, February 15, 2019.
4. If weather becomes issue, tournament manager will try to reschedule for the next weekend, all entrants will be notified. Entry fee will be refunded for those who cannot come to the rescheduled date. If next week scheduling not possible, tournament will be cancelled and money refunded.
5. Tournament will consist of four (4) games across eight (8) lanes, three (3) highest scores used. All entrants must sign and turn in official score record. Any errors MUST be reported immediately after bowling is completed.
6. Secretary of C-U 600 Bowling Club will have full charge of score sheets and conduct of the tournament.
7. No trophies, only monetary prizes awarded. At least one out of every five (5) entries will be paid. All prize fees collected will be returned 100% to participants. Secretary to determine prize list.
8. THERE WILL BE A ONE (1) GAME ROLL-OFF IN CASE OF TIE FOR CHAMPIONSHIP IN EACH DIVISION. Roll-off will be held immediately after all scores have been turned in and checked by tournament manager or her representative.
9. Tournament is scratch. Entry fee **\$25.00**; \$11.00 bowling fee, \$13.00 prize fund, \$1.00 expense.
10. Executive Board reserves right to verify average with Champaign-Urbana USBC secretaries and all local association secretaries, and league secretaries as needed. Verification will be done before tournament.
11. Decision of Executive Board of Champaign-Urbana 600 Bowling Club shall be final unless appeal is made in accordance with USBC Rule 329.
12. Any rules not covered above will be in accordance with USBC rules.
